ORGANIC MATURATION SYMPOSIUM

A symposium on Recognition of Thermal Maturation of Organic Materials in Sediments as it relates to hydrocarbon generation and migration has been scheduled for Wednesday, October 29, 1975, to precede the AASP Annual Meeting at the Houston Oaks Hotel, Galleria-Post Oak, Houston, Texas.

Speakers will present and discuss topics ranging from Geochemical Changes in Response to Thermal Alteration to actual microscopic measurement of thermal changes in both transmitted and reflected light. Following the formal presentations the participants will form a panel for questions and further discussion.

The Symposium will be both educationally and practically oriented. A novice in the area of thermal alteration will be introduced to basic concepts and techniques. The practioner will be broadened by a review of basic principles and actual exploration case histories.

A special registration fee of \$10.00 will be charged for this Symposium. Because of wide current interest in thermal alteration within the Petroleum Industry, it was recommended by the Executive Committee that non-AASP members also be invited to attend upon payment of the same registration fee. Organizer of and moderator for the Symposium is Jack D. Burgess. Presently scheduled speakers and the general area of their talks are:

<u>Jack Burgess</u>: Introduction and review of methods for determining thermal alteration of organic materials.

Geoff Bayliss: Chemical changes associated with thermal alteration of organic materials.

Bill Spackman: Early changes undergone by organic deposits in a peat swamp, Florida Everglades.

Frank Staplin: Kerogen color changes in response to thermal alteration.

John Grayson: Spore translucency.

Neeley Bostick: Vitrinite reflectance.

Logan Urban: Exploration application of thermal alteration.

<u>Wally Dow:</u> Exploration application of thermal alteration - Gulf Coast Basin.

There also will be exhibits of reflectance and other measurement techniques. Participants in the Symposium and the Annual Meeting are invited to bring their own residue preparations for use on the exhibitors equipment.

The Executive Committee has again approved a "Best Student Presentation Award" to encourage greater student participation in AASP meetings. The prize will be \$50.00. Any student in graduate school or who has received his degree within the same calendar year as the presentation will be eligible for the award. Papers co-authored with non-students will be eligible as long as they are delivered by the student. A panel of four judges, one of whom may be a student, will be responsible for the selection.

1975 MID-YEAR EXECUTIVE COMMITTEE MEETING

AASP's Board of Directors held its mid-year meeting in Suite 194 of the Ramada Inn in Tulsa, Oklahoma, on April 3rd and 4th. Present at all or part of the meeting were:

A copy of the meeting minutes may be obtained from the Secretary-Treasurer. Following is a brief summary of the business transacted:

- 1. Accepted the <u>Membership Report</u> which listed a total of 416 members as of April 1, 1975. There was a net increase of 38 members during 1974 and a net increase of 46 since the 1974 mid-year executive meeting.
- 2. Accepted the <u>Treasurer's Report</u> which listed total corporate assets as \$5,629.88 and showed total disbursements for the year to have been \$4,931.76. Most of the disbursement, \$4,754.94, was for purchase of members volumes of <u>Geoscience and Man</u> and payment of plate charges.
- 3. Accepted the Editor's Report which listed two Newsletters and No. 4 in the AASP Contribution Series as having been distributed since the Calgary meeting.
- 4. Discussed the status of past and future Annual Meetings:
 - (a) <u>Calgary, 1974</u>: Accepted as read W. W. Brideaux's report on the Calgary meeting and recommended copies be distributed to the Houston and Halifax committees.
 - (b) Houston, 1975: Reviewed Bill Elsik's report from the Houston Committee and commended him and his committee for their efforts. It was recommended that manuscripts be solicited from the Organic Maturation Symposium speakers either for publication in the Proceedings Volume or as a publication in the Contributions Series.
 - (c) Halifax, 1976: Reviewed the Halifax Committee's report and recommended that a letter to clarify certain ambiguities regarding publication and accommodations be drafted for the President's signature.
 - (d) Tulsa, 1977: Reviewed the Tulsa Committee's report, presented by Leonard Eames, and recommended polling the membership to determine whether a proposed two day field trip would be acceptable.
- 5. Reviewed old business:
 - (a) Financial Development Committee: Norm Norton

summarized his committee's efforts to raise money for AASP. There are possible sources but until an AASP Foundation is formed these sources would not be able to deduct their contributions. Bob Clarke is actively working on a plan for an AASP Foundation and with the IRS to get it approved as a tax deductible fund raiser.

- (b) International Commission for Palynology: Accepted Al Traverse's report as read by Dick Hedlund.
- (c) CIA Report: Accepted Colin McGregor's report on activity in the international arena. Colin's report included mailing lists for six foreign palynological or palynologically oriented organizations. These lists are basic to increasing the sale of AASP publications.
- (d) Nominating Committee Report: The slate of candidates nominated by the Committee is listed in a following item.
- (e) Stratigraphic Correlation Chart Committee Report:
 F. X. Miller's report was received subsequent to the meeting. Significant developments to date are funding by the U. S. Geological Survey for a full time project chairman and Dr. George V. Cohee's acceptance of chairmanship of the Data Bank and Chart Committee for the project.
- (f) Honorary Membership: Recommended balloting the membership to amend the By-Laws to permit awarding of Honorary Memberships.

6. Discussed new business:

- (a) Reprinting the Petrified Forest Field Guide: Recommended against reprinting, too costly.
- (b) Proposal to Increase Quality or Presentations at Meetings: Quality of slides were specifically discussed and a suggestion was made that "Stars of Excellence" be noted beside the name of speakers whose slides had been screened and judged to be of top quality.
- (c) Keeper of the Association's Archives: Following a moving and heart-rending appeal by Herb Sullivan, Norm Norton offered to contact authorities at the U. S. National Museum regarding storage of AASP documents.

- (d) <u>Increase of Membership Dues</u>: Recommended against increasing dues, for 1976.
- (e) Adjunct Functions at AASP Annual Meetings: Recommended against concurrent sessions for adjunct functions at Annual Meetings.
- (f) Tenth Anniversary Commemorative Volume: Herb Sullivan proposed a Treatise on Stratigraphic Palynology be compiled as a special publication to commemorate AASP's 10th Anniversary. The Executive Committee appointed Herb Sullivan as Editor for the Paleozoic section, Wayne Brideaux as Editor for the Mesozoic section and Bill Elsik as Editor for the Cenozoic section. These three people will prepare guidelines for the papers and submit them to the Executive Committee together with a provisional list of titles and authors.
- 7. Discussed such other old and new business as necessary to bring the Executive Committee up to date. The above summary is not complete as it pointedly ignores all references to cocktail parties, dinner parties and pecadilloes.

We hope many of the papers presented at Houston will be submitted for publication in the Houston Proceedings Volume. Those of you who are presenting papers will be sent a Manuscript Preparation Guide by Bill Elsik. If you intend to publish in the Proceedings Volume, we urge you to follow the Guide. It will save you a lot of future work and emotional upsets. Incomplete manuscripts are a no no. When forced to we will submit them to reviewers, but only for peer corroboration as to reason for rejection. Those of you who have plates should pay particular attention to the Plate Preparation Requirements. Plate costs have gone out of sight. They were \$65.00/ plate for the Anaheim Volume and could go as high as \$100.00/plate for the Houston Volume.

Last year we switched the deadline from December 1st to January 15th. There were numerous reasons for doing this, and it seems to have worked out to everyone's satisfaction. A meaningful deadline has to be based on the LSU Press production and priority schedules. However, as of now a January 15th deadline for manuscripts from the Houston meeting appears to be likely. This date will be confirmed or modified in the Editor's Report at the Annual Luncheon and Business Meeting.

AASP DUES

If you read the summary of the Executive Committee meeting you may have wondered why an increase in dues was considered. Do you know how your dues are spent? With the exception of a very small amount for special mailings, such as ballot returns, they have gone towards publishing papers presented at the Annual Meetings. Your AASP dues are \$10.00/year. AASP's expenditures break-down about as follows for 1975 on a per person basis:

A small carry-over in receipts from Annual Meeting registrations has permitted AASP to finance the deficit. But the above breakdown does not include the cost of producing and packaging our internal publications (Contribution Series, Membership Directory, Circulars, Newsletters) or their mailings. Their production, packaging and mailing costs have been obtained from the corporations, universities and industries with which your officers of the moment happened to be associated. Our dues could not have been maintained at the present rate except for the contribution of time and resources by many individuals and organizations.

Sometime, maybe this year, two Proceedings Volumes will come out in the same year. When that happens the \$5,000.00 presently in AASP's account will be exhausted. If costs continue to increase the account could be insufficient. However, the Executive Committee's philosophy is to cross that bridge when we get to it.

This brief and incomplete audit of the expenditure of your dues is submitted for your analysis. We hope it convinces you that you are getting your money's worth as a member of AASP.

The first part of the computer-based BIBLIOGRAPHY AND INDEX TO PALAEOBOTANY AND PALYNOLOGY covering the world literature during the period from 1950 to 1970 is now published. The BIBLIOGRAPHY contains approximately 25,000 bibliographic references of this brochure) of publications in palaeobotany, palaeopalynology, recent palynology, aeropalynology, mellitopalynology, archaeology, as well as bibliographies and biographies related to the fields in question. The INDEX contains all relevant key-words in a key-word-in-context list referring to the contents of the publications listed in the BIBLIOGRAPHY. Specific codes enable the user to find the references easily.

The second part of BIBLIOGRAPHY AND INDEX TO PALAEOBOTANY AND PALYNOLOGY will cover the world literature of our field of research from the beginning of the palaeobotanical and palynological sciences, that is from late Medieval times to the year 1949. This part will contain 45,000 literature references and will be ready for publication in 1976.

A MESSAGE FROM FRITZ

The Instituto de Investigaciones Palinologicas is a Foundation of the Caja de Ahorros y Monte de Piedad de Leon, in Leon, Spain. The Institute begun its existence on 1 January, 1975, and will soon move to its initial, semi-permanent location early this summer. Its official inauguration is scheduled for October, 1975.

The Institute will, when fully operational, work on applied and pure palynology and cover such fields as straight stratigraphic palynology, coal stratigraphy, in-situ fuel usage, organic maturation and related subjects. It will, in addition, deal with allergies caused by airborne particles and with the identification of the sources of these particles.

The palynology instrumentation is scheduled to be completed by 1976 or early 1977 at which time instrumentation and personnel hiring for the next field of endeavor of the Institute will/may begin. We expect to have ready for circulation the first report covering practical palynostratigraphic identification of the different North Spanish formations from Cambrian through Devonian, by the end of 1976; we will cover the Carboniferous in 1978, and the Mesozoic in 1980. These reports will be used for subsurface exploration and parts may be published.

At this moment, the scientific staff of the Institute consists of the following palynologists: Maria del Carmen R. Diez Rodriguez, Maria Amor Fombella Blanco, Rosa Maria Rodriguez Gonzalez and Fritz H. Cramer Diez. The institute is much interested in eatablishing a program of reprint exchange covering all fields of palynology.

PUBLICATIONS REQUEST

The Turkish Petroleum Company (TPAO) with the assistance of the United Nations Development Program has established a Petroleum Development Center in Ankara. By mid 1975 the Center will contain a well equipped palynology laboratory. The company is purchasing all the standard texts and subscribing to most of the palynologically oriented journals.
